For the transferee's well, please attach a surveyed legal description of the place of use and a recorded survey, if available, or, if for municipal use, include a copy of the CCN or attach a certified map showing the service site boundaries indicating the number of acres encompassed by the site.

Information about assigning an Authorized Representative:

- 1. If an Authorized Representative or agent of the transferee or transferor will sign this application, the Authorized Representative or agent shall provide written evidence of his or her authority to represent the transferee or transferor, as appropriate.
- 2. If the transferee or transferor is an individual or a partnership doing business under an assumed name, the transferee or transferor shall attach an assumed name certificate from the county clerk of the county in which the principal place of business is located and from the Secretary of State, if applicable.
- 3. Joint transferees or transferors shall select one among them to pursue the application with the District and shall attach written evidence of such representation.
- 4. If the transferee or transferor is an estate or guardianship, a current copy of the letters testamentary issued by the court shall be attached to the application.
- 5. If the transferee or transferor is a corporation, public district, county, municipality, or other corporate entity, written evidence in the form of bylaws, charters, or resolutions specifying the authority of the official to apply for the transfer shall be submitted. A corporation may file a corporate affidavit as evidence of the official's authority to sign.
- 6. If either applicant is acting as trustee for another, the applicant shall disclose in writing the nature of the trust agreement and provide the name and current address of each trust beneficiary to the District.
